DISCLOSURE EX ART. 13 OF D.LGS. N. 196/2003
The undersigned declares to have been
informed that the Legislative Decree no. 196/2003 (Code regarding the protection of personal data)
provides for the protection of people and other subjects regarding the processing of personal data.
According to the indicated legislation, this treatment will be based on principles of correctness,
lawfulness and transparency and protection of confidentiality. Pursuant to article 13 of Legislative
Decree n. 196/2003, I have been informed of the following circumstances: 1) the data provided and
my image will be used for advertising and promotional purposes by AIPM, in the person of the pro
tempore legal representative, based in Trento, Via Lidorno, n. 3; 2) the owner ensures the use of
suitable tools to guarantee the security and confidentiality of the personal data supplied by me; 3)
the processing of the collected data will be carried out by electronic and paper means; 4) the
granting of consent to the processing of personal data is optional; 5) the data provided may be
known by the administrative staff of the AIPM as data processors pursuant to art. 30 Legislative
Decree n. 196/2003; 6) the data controller is AIPM, in the person of its pro tempore legal
representative, based in Trento, Via Lidorno, n. 3 and the person in charge of the treatment is mr.
Francesco Frezza, as AIPM pro tempore Legal Representative; 7) at any time I will be able to exercise
my rights towards the data controller, pursuant to art. 7 of Legislative Decree no. 196/2003 which
is reproduced here in full:
Art. 7 - Right of access to personal data and other rights 1. The interested party has the right to
obtain confirmation of the existence or not of personal data concerning him, even if not yet
registered, and their communication in an intelligible form. 2. The interested party has the right to
be informed: a) of the origin of the personal data; b) the purposes and methods of treatment; c)
the logic applied in case of treatment carried out with the aid of electronic instruments; d) of the
identification details of the owner, of the managers and of the representative appointed pursuant to
article 5, paragraph 2.e) of the subjects or categories of subjects to whom the personal data may
be communicated or who can learn about them as appointed representative in the territory of the
State, managers or agents. 3. The interested party has the right to obtain: a) updating, rectification
or, when interested, integration of data; b) the cancellation, transformation into anonymous form
or blocking of data processed in violation of the law, including data which need not be kept for the
purposes for which the data were collected or subsequently processed; c) the certification that the
operations referred to in letters a) and b) have been brought to the attention, also as regards their
content, of those to whom the data have been communicated or disseminated, except in the case
in which this fulfillment occurs proves impossible or involves the use of means manifestly
disproportionate to the protected right. 4. The interested party has the right to object, in whole or
in part: a) for legitimate reasons, to the processing of personal data concerning him, even if pertinent
to the purpose of the collection; b) to the processing of personal data concerning him for the purpose
of sending advertising materials or direct selling or for carrying out market research or commercial
communication.
